Eligibility

Open to all artists 18 years old and over. Entries must be of **original design**. No gicleé or other mechanical reproductions. Work must be executed within the last two years.

Media/Size

All media accepted. Wall-hung or 2D artwork must be framed or gallery wrapped, wired, ready to hang, and not exceed 60 inches wide or 96 inches high. 3D artwork must be self-standing or fit on a 36x36 inch pedestal. **All artwork must be able to be handled by one person. No work can be suspended from the ceiling. Any accessories needed for display must be included.** Pedestals provided by gallery. The gallery reserves the right to install accepted works in a manner deemed necessary for exhibition and/or security reasons.

Sales

A 50% commission will be taken on work sold.
Artwork does not need to be for sale.

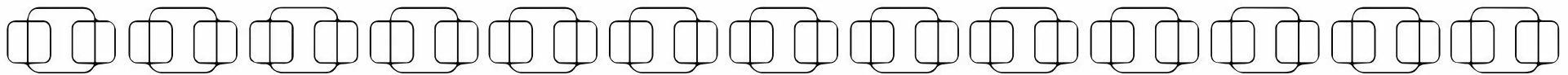

a sealed bag. Crates must be simple to open
and reseal. **Weight & size must be able to be handled
by one person. Indicate value for return shipping
insurance if not waived.**

\$40 for up to 3 pieces. 2 images per piece may be
submitted. This may include a 2nd angle or detail.
